INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 421-Representative Cera.

To enact section 4905.311 of the Revised Code to permit the Governor to terminate reasonable arrangements between an electric distribution utility or public utility electric light company and certain mercantile customers.

To enact sections 4781.56, 4975.01, 4975.02, 4975.03, 4975.04, 4975.05, and 5321.041 of the Revised Code to create requirements regarding the measurement and billing of tenant and manufactured home park resident public utility service.

H. B. No. 423-Representatives Milkovich, Wachtmann.

To amend section 5101.141 and to enact section 5101.1411 of the Revised Code to extend the age for which a person is eligible for federal payments for foster care under Title IV-E to age twenty-one.

REPORTS OF STANDING AND SELECT COMMITTEES AND BILLS FOR SECOND CONSIDERATION

Representative Fedor submitted the following report:

The standing committee on Education to which was referred **H. B. No. 416**-Representatives Burkley, Hill, et al., having had the same under

consideration, reports it back with the following amendments and recommends its passage when so amended.

RE: SCHOOLS-CALAMITY DAYS-2013-14 SCHOOL YEAR-ALLOW UP TO 4 EXTRA

Representative Stebelton moved to amend the title as follows:

Add the names: "Smith, Bishoff."

Representative Brenner moved to amend as follows:

In line 39, after "4." insert "A school district, STEM school established under Chapter 3326. of the Revised Code, or a chartered nonpublic school may apply the provisions of this section after applying the additional excused days for the 2013-2014 school year authorized under Section 733.10 of Am. Sub. H.B. 59 of the 130th General Assembly, as amended by this act.

Notwithstanding anything to the contrary in the contingency plan it adopted for the 2013-2014 school year under division (A) of former section 3313.482 of the Revised Code or division (B) of the version of section 3317.01 of the Revised Code in effect prior to July 1, 2014, if during the 2013-2014 school year a school district, STEM school, or chartered nonpublic school closes or evacuates any school building for any of the reasons set forth in division (B) of the version of section 3317.01 of the Revised Code in effect prior to July 1, 2014, or as a result of a bomb threat or any other report of an alleged or impending explosion, and if, as a result of the closing or evacuation, the school district, STEM school, or chartered nonpublic school is unable to meet, for the 2013-2014 school year, the requirements of the versions of sections 3313.48, 3313.481, and 3317.01 of the Revised Code in effect prior to July 1, 2014, regarding the number of days schools must be open for instruction or the requirements of the state minimum standards for the school day that are established by the Department of Education regarding the number of hours there must be in the school day, the school district, STEM school, or chartered nonpublic school may increase the length of one or more other school days during the 2013-2014 school year for the school that was closed or evacuated, in increments of one-half hour, to make up the number of hours or days that the school building in question was so closed or evacuated for the purpose of satisfying the requirements of those sections.

A school district, STEM school, or chartered nonpublic school that makes up, as described in this section, all of the hours or days that its school buildings were closed or evacuated for any of the reasons identified in this section shall be deemed to have complied with the requirements of the versions of sections 3313.48, 3313.481, and 3317.01 of the Revised Code in effect prior to July 1, 2014, regarding the number of days schools must be open for instruction and the requirements of the state minimum standards regarding the number of hours there must be in the school day for the 2013-2014 school year.

In line 44, delete "fiscal" and insert "the 2013-2014 school"; delete "2014" $\,$

In line 2 of the title, delete "payment in fiscal"

Delete line 3 of the title

In line 5 of the title, delete "permitted" and insert "additional school"; delete "fiscal year 2014" and insert "the 2013-2014 school year; to authorize, for the 2013-2014 school year, schools to make up in half-hour increments "calamity" days missed in excess of the number of days permitted by law;"
