To enact sections 3701.66 and 3701.661 of the Revised Code to provide for development of educational materials promoting infant safe-sleeping practices and for review of the materials with the parent, guardian, or caregiver of each newborn infant.

BILLS FOR THIRD CONSIDERATION

Am. H. B. No. 416-Representatives Burkley, Hill.

To amend Section 733.10 of Am. Sub. H.B. 59 of the 130th General Assembly to permit up to four additional school "calamity" days in the 2013-2014 school year; to authorize, for the 2013-2014 school year, schools to make up in half-hour increments "calamity" days missed in excess of the number of days permitted by law; and to declare an emergency, was taken up for consideration the third time.

The question being, "Shall the emergency clause stand as part of the bill?"

Representative Slaby moved that **Am. H. B. No. 416**-Representatives Burkley, Hill, et al., be informally passed and retain its place on the calendar.

The motion was agreed to.
