The House met pursuant to adjournment.

### INTRODUCTION OF BILLS

The following bills were introduced:

### H. B. No. 449-Representative Gonzales.

To amend section 3333.31 and to enact section 3333.311 of the Revised Code with respect to residency status for certain veterans, spouses, and dependents at state institutions of higher education.

### H. B. No. 450-Representative Patterson.

To amend sections 5739.02 and 5739.05 of the Revised Code to provide a three-day sales tax "holiday" each August during which sales of back-to-school clothing, school supplies, personal computers, and personal computer accessories are exempt from sales and use taxes.

### H. B. No. 451-Representative Gerberry.

To amend section 101.28 of the Revised Code to require joint conventions of the General Assembly held for the purpose of hearing the Governor's annual message on the condition of the state to be held in the Hall of the House of Representatives.
