The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Buchy was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 67-Representatives Schuring, Ramos. Cosponsor: Representative Amstutz.

To amend section 145.037 of the Revised Code to delay determinations by the Public Employees Retirement System of eligibility for retirement system membership and to declare an emergency.

H. B. No. 68-Representative Maag.

Cosponsors: Representatives Adams, J., Becker, Brenner, Buchy, Gonzales, Hood, Johnson, Mallory, McGregor, Pillich, Ramos, Retherford, Stebelton, Thompson.

To amend section 4511.21 of the Revised Code to increase the speed limit on interstate freeways outside urbanized areas from 65 to 70 miles per hour for all vehicles.

H. B. No. 69-Representatives Maag, Mallory. Cosponsors: Representatives Adams, J., Becker, Blessing, Buchy, Dovilla, Hood, Huffman, Milkovich, Ramos.

To enact section 4511.095 and to repeal sections 4511.092 and 4511.094 of the Revised Code to prohibit the use of traffic law photo-monitoring devices by municipal corporations, counties, townships, and the State Highway Patrol to detect traffic signal light and speed limit violations.

S.B. 20 of the 120th General Assembly, as subsequently amended, to require the Registrar of Motor Vehicles to establish an electronic motor vehicle insurance verification system, to require an insurance company to notify the Registrar upon the cancellation or lapse of a motor vehicle liability insurance policy, to eliminate the financial responsibility random verification program of the Bureau of Motor Vehicles, and to make other changes in the procedures for verifying proof of financial responsibility regarding a motor vehicle.

To enact section 5.2279 of the Revised Code to designate October as "Manufacturing Month."

TO PROVIDE THAT A PERSON WHO HOLDS A CURRENT, VALID DRIVER'S LICENSE FROM ANOTHER STATE BE REQUIRED TO PASS ONLY VISION SCREENING IN ORDER TO BE ISSUED A DRIVER'S LICENSE, AND TO AMEND THE VERSION OF SECTION 4507.05 OF THE REVISED CODE THAT IS SCHEDULED TO TAKE EFFECT JANUARY 1, 2017, TO CONTINUE THE PROVISIONS OF THIS ACT ON AND AFTER THAT EFFECTIVE DATE.
