### INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 457-Representative Slaby.

To enact section 5.2288 of the Revised Code to designate March 14, 2014, as "Lee Strawn Day" in honor of Lee Strawn's service to the state and to declare an emergency.

Said bill was considered the first time.

# REPORTS OF STANDING AND SELECT COMMITTEES AND BILLS FOR SECOND CONSIDERATION

Representative Fedor submitted the following report:

The standing committee on Education to which was referred **H. B. No. 334**-Representatives Hayes, Hottinger, et al., having had the same under consideration, reports it back with the following amendment and recommends its passage when so amended.

## RE: SCHOOL EXPULSIONS-ACTIONS THAT ENDANGER HEALTH AND SAFETY OF STUDENTS/EMPLOYEES

Representative Hayes moved to amend as follows:

In line 128, delete " , one of which" and insert " . The superintendent shall provide a copy of these conditions in writing to the district board, the pupil, and the pupil's parent, guardian, or custodian at the beginning of the expulsion period.

One of the conditions developed by the superintendent"

In line 129, after " <u>assessment</u>" insert " <u>to determine whether the pupil</u> <u>poses a danger to the pupil's self or to other pupils or school employees. The assessment shall be</u>"

In line 133, delete everything after the underlined period

Delete lines 134 and 135

In line 136, delete everything before the underlined period and insert " If the psychiatrist, psychologist, or school psychologist is not employed or contracted by the district, the cost of the assessment shall be referred for payment to the pupil's health insurance. Any costs not covered by the pupil's health insurance shall be split equally between the district and the pupil's parent, guardian, or custodian. The district shall pay in full for an assessment completed by a psychiatrist, psychologist, or school psychologist that is employed or contracted by the district"

In line 142, delete " student" and insert " pupil"

In line 171, after "(c)" insert "Prior to the end of the original expulsion period or of an extended expulsion period, if the pupil has met all of the conditions developed by the superintendent at the beginning of the expulsion period, the superintendent may reduce the expulsion on a case-by-case basis. In making the determination, the superintendent shall comply with the district's policy regarding the reduction of an expulsion period, adopted pursuant to section 3313.661 of the Revised Code.

(d)"

In line 183, delete " (d)" and insert " (e)"

In line 193, delete " (e)" and insert " (f)"

In line 196, delete the second underlined period

Between lines 441 and 442, insert:

" (3) On and after July 1, 2014, the meaning of the term "school day" shall be construed in the manner prescribed by section 3313.481 of the Revised Code."

The motion was agreed to and the bill so amended.
