The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Burkley was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 467-Representatives Butler, Romanchuk.

Cosponsors: Representatives Terhar, Amstutz, Blair, Boose, Brenner, Grossman, Hood, Perales, Retherford, Roegner, Thompson.

To amend section 126.02 and to enact sections 101.61, 103.31, 103.32, 103.33, 103.34, 103.35, 103.36, 103.37, and 103.38 of the Revised Code to provide for the preparation of a state biennial budget independent of that submitted by the Governor and to authorize the Legislative Service Commission, upon the request of the Speaker of the House of Representatives or the President of the Senate, to arrange for an independent actuarial review of a proposed bill, specified analyses of economic policy initiatives and state benchmarking data, and a study of the state's long-range financial outlook.

H. B. No. 468-Representatives Sears, McGregor.

Cosponsors: Representatives Becker, Hackett, Henne.

To amend sections 505.871, 4501.25, 4505.061, 4738.01, 4738.02, 4738.03, 4738.17, and 4738.99, to enact sections 3937.19, 4738.021, 4738.022, 4738.023, and 4738.031, and to repeal section 4738.18 of the Revised Code relative to salvage motor vehicles and junk motor vehicles.

H. B. No. 469-Representatives Johnson, Scherer.

Cosponsors: Representatives Hill, Stinziano, Cera, Barborak, Young, Pillich, Antonio, Bishoff, Smith.

To amend sections 4510.021, 4510.11, 4510.13, 4510.14, 4510.17, 4510.43, 4510.44, 4510.46, 4511.19, and 4511.197 and to enact section 4510.022 of the Revised Code to allow, by court order, a first-time alcohol-related OVI offender to drive with an ignition interlock device rather than under court-ordered limited driving privileges as in current law, to eliminate the

fifteen-day period in current law during which such an offender is subject to a driver's license suspension without limited driving privileges, and to make other changes to the law governing OVI offenses.

Said bills were considered the first time.

On motion of Representative Landis, the House adjourned until Tuesday, March 11, 2014 at 9:00 o'clock a.m.
