INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 116-Representative Pelanda.

Cosponsors: Representatives Gonzales, Hackett, Young, Stebelton.

To amend sections 4729.01, 4729.531, 4729.532, 4729.54, and 4729.55 and to enact sections 955.151, 959.134, 3719.091, 4729.533, 4729.534, 4729.535, 4729.542, 4729.991, and 4741.201 of the Revised Code to govern the chemical capture of animals, eliminate references to pentobarbital in statutes regulating animal euthanasia, and terminate the chemical capture provisions of this act by repealing sections 955.151, 959.134, 3719.091, 4729.533, 4729.534, 4729.535, 4729.542, 4729.991, and 4741.201 of the Revised Code five years after its effective date.

H. B. No. 117-Representatives Hackett, Stinziano.

Cosponsors: Representatives Henne, Sears.

To amend section 4123.351 and to enact sections 3964.01 to 3964.15, 3964.17, 3964.171, 3964.172, 3964.173, 3964.174, 3964.175, 3964.176, 3964.177, 3964.178, 3964.179, 3964.1710, 3964.18, 3964.20, and 3964.21 of the Revised Code to provide for the operation of captive insurance companies in Ohio.

Said bills were considered the first time.
