**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 143**-Representatives DeVitis, Butler.

Cosponsors: Representatives Retherford, Brenner, Boose, Young, Lundy, Adams, J., Sprague, Roegner, Becker, Romanchuk, Huffman, Blair, Gonzales.

To amend section 4123.29 of the Revised Code to require the Administrator of Workers' Compensation to include in the notice of premium rate that is applicable to an employer for an upcoming policy year the mathematical equation used by the Administrator to determine the employer's premium rate.

**H. B. No. 144**-Representative Kunze.

Cosponsors: Representatives Gonzales, Duffey, Hood, Ruhl, Strahorn, Becker, Pillich, Grossman, Hackett, Stebelton.

To amend sections 2151.87, 2927.02, 2927.021, and 2927.022 of the Revised Code to include alternative nicotine products within the restrictions that currently apply to the sale or distribution to, and possession or use by, minors of cigarettes and other tobacco products and to declare an emergency.

**H. B. No. 145**-Representative Henne.

Cosponsors: Representatives Antonio, Brenner, Fedor, Sykes, Duffey, Stebelton, Wachtmann, Foley, Stinziano, Rogers.

To amend sections 4511.132 and 4511.27 of the Revised Code to provide that when a motor vehicle passes a bicycle the safe passing distance to the left is three feet, and to alter the protocol for proceeding into an intersection that has malfunctioning traffic lights.

**H. B. No. 146**-Representative Gonzales.

To amend sections 4725.42 and 4725.43 of the Revised Code to modify the composition of the Optical Dispensers Board.

**H. B. No. 147**-Representatives Patmon, Wachtmann.

Cosponsors: Representatives Ramos, Barnes, Hackett, Burkley, Grossman.

To enact section 4731.73 of the Revised Code to require a surgeon performing a mastectomy, lymph node dissection, or lumpectomy in a hospital to guide the patient and provide referrals in accordance with the standards of the National Accreditation Program for Breast Centers and to name this act the "Lizzie B. Byrd Act."

**H. B. No. 148**-Representatives Driehaus, Hagan, R.

Cosponsors: Representatives Antonio, Lundy, Boyd.

To amend sections 1509.01, 1509.02, 1509.03, 1509.05, 1509.06, 1509.08, 1509.21, 1509.22, 1509.222, 1509.223, and 1509.224, to enact section 1509.051, and to repeal section 1509.226 of the Revised Code to prohibit land application and deep well injection of brine, to prohibit the conversion of wells, and to eliminate the injection fee that is levied under the Oil and Gas Law.
