The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative McGregor was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 541-Representatives Winburn, Blair.

To amend sections 109.73, 955.11, 955.12, 955.22, 955.222, and 955.99 and to enact sections 955.13, 955.223, and 955.60 of the Revised Code to revise provisions of the Dogs Law governing nuisance, dangerous, and vicious dogs and confinement and restraint of dogs, to revise enforcement of that Law, to require the Attorney General to establish a registry of violations of that Law and related complaints, and to establish a notification process regarding complaints.

H. B. No. 542-Representative Barborak.

Cosponsors: Representatives Butler, Rogers, Stinziano.

To amend sections 2929.01, 2929.18, and 2929.28 of the Revised Code to permit a sentencing court to order an offender to reimburse a county, township, municipal corporation, or state law enforcement agency for funds expended by the law enforcement agency to purchase a drug, controlled substance, or controlled substance analog from the offender during the agency's investigation of a drug offense.

H. B. No. 543-Representative Barborak.

Cosponsors: Representatives Fedor, Rogers, Ramos.

To amend section 2933.24 of the Revised Code to specify that a search warrant must be executed within 10 days.

H. B. No. 544-Representative Grossman.

To enact section 5.2296 of the Revised Code to designate September as "Parkinson's Disease Awareness Month."

H. B. No. 545-Representative Gonzales.

To enact sections 4781.401, 4934.01, 4934.02, 4934.03, 4934.05, 4934.06, 4934.07, 4934.09, 4934.11, 4934.13, 4934.15, 4934.17, 5311.082, and 5321.061 of the Revised Code regarding master metering and submetering for public utility service to premises administered by a landlord, condominium unit owners association, or manufactured home park operator.

H. B. No. 546-Representatives Dovilla, Antonio.

To amend sections 109.572, 4776.01, and 4776.20 and to enact sections 4780.01 to 4780.15 and 4780.99 of the Revised Code to require the licensure of music therapists and to require the to regulate the licensure and practice of music therapists.

H. B. No. 547-Representatives Fedor, Patterson.

Cosponsors: Representatives Foley, Gerberry, Williams, Pillich, Antonio, Driehaus.

To amend section 3314.03 of the Revised Code with regard to the evaluation of community school teachers.

H. B. No. 548-Representative Fedor.

Cosponsors: Representatives Patterson, Driehaus, Antonio, Boyd, Slesnick, Gerberry.

To establish a committee to study the effectiveness of community schools and community school regulations.

H. B. No. 549-Representative Fedor.

Cosponsors: Representatives Foley, Driehaus, Antonio, Lundy, Cera, Stinziano, Reece, Ramos, Rogers, Boyce, Phillips, Patterson, Strahorn, Clyde, Sheehy, Heard, Ashford, Winburn, Gerberry, Sykes.

To amend section 3313.608 and to enact section 3317.26 of the Revised Code and to amend Sections 263.10 and 263.255 of Am. Sub. H.B. 59 of the 130th General Assembly to delay until the 2015-2016 school year retention of third grade students and requirements for teachers who provide instruction to third grade students under the Third Grade Reading Guarantee, to provide for a subsidy for reading intervention services, and to make an appropriation.

H. B. No. 550-Representative Ramos.

Cosponsors: Representatives Foley, Antonio, Lundy, Barborak.

To enact sections 3333.101 and 3333.102 of the Revised Code to create the Frances Lewandowski Memorial Medical Research Fund and the Medical

University Research Reserve Fund to provide grants to public medical schools for research on terminal, chronic, or currently incurable diseases, to require the General Assembly annually to appropriate for those grants an amount equal to not less than one-tenth of one per cent of the total prior year General Revenue Fund appropriations, and to make an appropriation.

H. B. No. 551-Representatives Hagan, R., Sheehy.

Cosponsors: Representatives Foley, Antonio, Fedor, Mallory, Williams, Phillips, Ramos, Pillich, Gerberry, Ashford.

To enact section 4999.09 of the Revised Code to require the crews of freight trains to consist of at least two individuals.

H. B. No. 552-Representative Stautberg.

Cosponsors: Representatives Beck, Becker, Driehaus, Grossman, Milkovich, Rosenberger, Ruhl, Slaby, Stinziano.

To enact section 3701.66 of the Revised Code regarding Down syndrome and patient information.

Said bills were considered the first time.
