INTRODUCTION OF BILLS

To enact section 2919.194 of the Revised Code to provide that a health care professional is not subject to civil or criminal liability for failure to comply with abortion-related requirements in certain circumstances.

To amend sections 2329.151, 2329.17, 2329.18, 2329.19, 2329.20, 2329.271, 2329.28, 2329.34, and 2329.39 and to enact sections 2329.152 and 2329.311 of the Revised Code to permit private selling officers to conduct judicial sales of real property.

H. B. No. 587-Representatives Lundy, Budish.

To enact section 9.318 of the Revised Code to permit political subdivisions to establish a buy local Ohio program.

H. B. No. 588-Representatives Huffman, Wachtmann.

To amend sections 2133.02, 2133.21, 2133.211, 2133.23, 2133.24, 2133.25, 2133.26, 3795.03, and 4730.09; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 2133.211 (2133.23), 2133.23 (2133.24), 2133.24 (2133.25), 2133.25 (2133.26), and 2133.26 (2133.27); to enact new section 2133.22 and sections 2133.28 to 2133.47; and to repeal section 2133.22 of the Revised Code to establish procedures for the

use of medical orders for life-sustaining treatment and to make changes to the laws governing DNR identification and orders.
