Representative Pelanda was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 604**-Representative Clyde.

Cosponsors: Representatives Antonio, Ashford, Bishoff, Celebrezze, Fedor, Foley, Hagan, R., Heard, Phillips, Ramos, Redfern, Reece, Slesnick, Strahorn.

To amend section 4112.02 and to enact sections 1751.68 and 3923.84 of the Revised Code to require health insurers to provide coverage for contraceptive drugs and devices approved by the United States Food and Drug Administration and to prohibit employment discrimination under the Ohio Civil Rights Law on the basis of reproductive health decisions made by a person or a person's dependent or on the basis of the employer's personal beliefs about drugs, devices, and services related to reproductive health.

**H. B. No. 605**-Representatives Adams, J., Retherford.

Cosponsors: Representatives Beck, Becker, Buchy, Hood, Lynch, Maag.

To enact section 9.05 of the Revised Code to prohibit state agencies from entering into an agreement with the federal government to provide temporary housing for aliens who are not legally present in the United States and to make political subdivisions or persons ineligible to receive state funds if they enter into an agreement with the federal government to provide such housing for those aliens.

Said bills were considered the first time.
