# INTRODUCTION OF BILLS

H. B. No. 240-Representatives Adams, J., Becker.

To amend sections 323.17, 3501.01, 5705.194, 5739.021, and 5739.026 of the Revised Code to eliminate the ability to conduct special elections in February and August.

# H. B. No. 241-Representative Hagan, C.

Cosponsors: Representatives Becker, Buchy, Grossman, Hood, Stebelton.

To amend section 2907.03 of the Revised Code to prohibit an employee of a public or nonpublic school or institution of higher education from engaging in sexual conduct with a minor who is enrolled in or attends that public or nonpublic school or who is enrolled in or attends that institution of higher education and is also enrolled in or attends a public or nonpublic school.

Said bills were considered the first time.
