The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 253-Representative Rogers.

Cosponsors: Representatives Foley, Hagan, R., Cera, Patterson, Sheehy, Antonio, Lundy, Stinziano, Phillips, Ramos, Ashford.

To enact section 4113.14 of the Revised Code to prohibit certain employers from requiring employees to accept the employees' pay in the form of a paycheck card.

H. B. No. 254-Representatives Lynch, Retherford.

Cosponsors: Representatives Beck, Becker, Brenner, Buchy, Hood, Roegner, Thompson.

To amend section 3333.31 of the Revised Code to prohibit state institutions of higher education from providing in-state residency status to undocumented aliens.

H. B. No. 255-Representative Becker.

Cosponsor: Representative Lynch.

To amend sections 5163.01, 5163.06, 5163.061, 5163.07, 5166.01, and 5166.04, to enact new section 5163.09, and to repeal sections 5163.09, 5163.091, 5163.092, 5163.093, 5163.094, 5163.095, 5163.096, 5163.097, 5163.098, 5163.099, and 5163.0910 of the Revised Code to revise the law governing eligibility for the Medicaid program and to abolish the Medicaid Buy-In for Workers with Disabilities Program.

Said bills were considered the first time.
