The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Ruhl was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 264-Representatives Wachtmann, Barnes.

Cosponsors: Representatives Antonio, Beck, Grossman, Milkovich, Brown.

To amend sections 3313.713, 3314.03, 3326.11, and 3328.24 and to enact section 3313.7110 of the Revised Code and to amend the version of section 3326.11 of the Revised Code that is scheduled to take effect on July 1, 2014, regarding care for students with diabetes in schools.

H. B. No. 265-Representatives Stinziano, Grossman.

Cosponsors: Representatives Driehaus, Mallory, Patmon, Reece, Sheehy, Strahorn.

To amend sections 737.051, 737.161, 3501.29, 3781.111, 4503.44, and 4511.69 of the Revised Code to alter the designation of special parking locations for persons who have a disability that limits or impairs the ability to walk by designating such locations as "accessible parking spaces" or "disability parking spaces."

H. B. No. 266-Representative Becker.

Cosponsors: Representatives Lynch, Maag.

To amend sections 3501.05, 3509.03, 3509.04, 3509.05, 3509.06, 3509.08, 3509.09, 3511.02, 3511.04, 3511.05, 3511.06, 3511.07, 3511.08, 3511.09, 3511.10, 3511.11, and 3511.13 and to enact section 3501.40 of the Revised Code to generally prohibit the mailing of unsolicited election forms and prepayment of postage for the return of election forms and to clarify that a board of elections is responsible to send and receive absent voter's ballot materials.

Said bills were considered the first time.
