The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative McClain was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 638**-Representatives Beck, Adams, J. Cosponsor: Representative Brown.

To amend section 131.43 of the Revised Code to require an annual deposit to the Budget Stabilization Fund equal to 5% of General Revenue Fund revenues for the preceding fiscal year.

**H. B. No. 639**-Representatives Beck, Adams, J. Cosponsors: Representatives Retherford, Becker.

To amend sections 5747.02 and 5747.41 and to enact section 5747.027 of the Revised Code to phase out the income tax and income tax expenditures over ten years.

**H. B. No. 640**-Representatives Sprague, Smith. Cosponsors: Representatives Antonio, Barborak, Buchy, Duffey, Stebelton.

To amend sections 119.03, 3719.01, 3719.41, and 3719.43 and to enact sections 109.44, 3719.45, and 3719.46 of the Revised Code authorizing the Ohio Attorney General to place certain substances on controlled substances schedule I.

H. B. No. 641-Representative Celebrezze.

Cosponsors: Representatives Barborak, Cera, Foley, Beck, Antonio, Fedor, O'Brien, Hagan, R.

To amend section 959.99 and to enact sections 959.30 to 959.34 of the Revised Code to require violators of specified statutes in the Animal Cruelty Law to register with the Attorney General, to require the Attorney General to establish a registry of those violators, and to prohibit an animal shelter from placing for adoption an animal in the shelter's care with such a violator. H. B. No. 642-Representative Fedor.

Cosponsors: Representatives Clyde, Bishoff, Stinziano, Hagan, R., Lundy, Hood, Gerberry, Barborak, Mallory, Slesnick, Phillips, Ramos, Foley, Cera, Antonio, Patterson, Driehaus, Sheehy, Rogers.

To amend section 3302.036 of the Revised Code and Section 13 of Am. Sub. H.B. 487 of the 130th General Assembly to provide a three-year performance rating safe harbor for school districts and schools, to provide a three-year student academic growth rating safe harbor for teacher evaluations and when making decisions regarding teachers' employment and compensation, and to declare an emergency.

H. B. No. 643-Representative Duffey.

To review provisions of the Election Law to ensure that Ohioans' constitutional right to free speech is protected.

Said bills were considered the first time.
