# INTRODUCTION OF BILLS

The following bills were introduced:

# H. B. No. 328-Representatives Young, Hagan, C.

Cosponsors: Representatives Adams, J., Amstutz, Becker, Brenner, Hood, Roegner.

To amend section 131.35 of the Revised Code to modify the authority of the Controlling Board to approve certain expenditures.

# H. B. No. 329-Representative Hall.

Cosponsors: Representatives Retherford, DeVitis, Henne, Letson, Romanchuk, Brown, Thompson, Grossman, Scherer, Smith, Blair, Terhar, Hackett, Conditt.

To require the Director of Budget and Management to make payments on the balance of amounts borrowed by the state from the federal government to issue unemployment benefits and to make an appropriation.

# H. B. No. 330-Representative Barborak.

Cosponsors: Representatives Hagan, R., Slesnick.

To enact section 5.093 of the Revised Code to designate the song entitled "Ohio" as the official state country song.

# H. B. No. 331-Representatives Romanchuk, Letson.

Cosponsors: Representatives Hackett, Adams, J., Sears.

To amend sections 3905.01 and 3905.06 and to enact section 3905.063 of the Revised Code to regulate the licensure of limited lines travel insurance agents in this state.

H. B. No. 332-Representatives Wachtmann, Antonio.

Cosponsors: Representatives Sprague, Sheehy.

To enact sections 3719.62, 4715.303, 4723.283, 4725.191, 4730.252, and 4731.229 of the Revised Code to establish standards and procedures for opioid treatment of chronic, intractable pain resulting from noncancer conditions and to require that professional disciplinary action be taken for failing to comply with those standards and procedures.

Said bills were considered the first time.
