INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 340-Representative Becker.

Cosponsors: Representatives Hood, Lynch, Thompson.

To enact sections 2923.26 to 2923.30 of the Revised Code to provide protections from federal provisions related to interstate commerce for firearms, firearm accessories, and ammunition manufactured and remaining in Ohio.

H. B. No. 341-Representative Smith.

To amend sections 4715.30, 4715.302, 4723.28, 4723.487, 4725.092, 4725.19, 4729.16, 4729.80, 4730.25, 4730.53, 4731.055, and 4731.22 and to enact section 4729.282 of the Revised Code to prohibit a controlled substance that is a schedule II drug or contains opioids from being prescribed or dispensed without review of patient information in the State Board of Pharmacy's Ohio Automated Rx Reporting System.

H. B. No. 342-Representatives Brenner, Driehaus.

To amend Section 263.325 of Am. Sub. H.B. 59 of the 130th General Assembly to permit an educational service center to be a partner or the lead applicant of an education consortia seeking a grant under the Straight A Program and to modify the goals of projects supported by the program.

H. B. No. 343-Representative Stebelton.

To amend section 3313.617 of the Revised Code, to amend the versions of sections 3317.01 and 3317.022 that are scheduled to take effect July 1, 2014, and to amend section 3314.08 and to enact sections 3314.362, 3314.38, 3317.036, and 3317.24 of the Revised Code on July 1, 2014, regarding educational programs for certain students and individuals who have not received a high school diploma.
