INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 394-Representatives Smith, Antonio.

To amend section 4729.41 of the Revised Code regarding the authority of pharmacists and pharmacy interns to administer immunizations.

H. B. No. 395-Representative Ramos.

Cosponsors: Representatives Foley, Sheehy, Hagan, R., Milkovich, Reece, Ashford, Williams, Antonio, Stinziano, Pillich, Patterson, Phillips, Heard, Boyce.

To enact section 5101.543 of the Revised Code to require the Director of Job and Family Services to request a federal waiver of time limits for certain Supplemental Nutrition Assistance Program recipients.

H. B. No. 396-Representative Becker.

Cosponsors: Representatives Hood, Stebelton.

To amend section 5747.08 of the Revised Code to allow married couples to elect to file either separate state tax returns or a joint state return, irrespective of their federal filing status, and to declare an emergency.

H. B. No. 397-Representative Hill.

Cosponsors: Representatives Buchy, Burkley, Derickson, Hottinger, Ruhl, Smith.

To amend sections 4549.02 and 4549.021 of the Revised Code to increase the penalty for violations of failure to stop after an accident and failure to stop after a nonpublic road accident that result in the death of a person or serious physical harm to a person.

H. B. No. 398-Representative Sears.

Cosponsors: Representatives Grossman, Sprague, Blessing.

To create the Veterans and Medicaid Eligibility Study Committee and the Health Care Access and Innovation Study Committee.

Said bills were considered the first time.
