**REPORTS OF REFERENCE AND BILLS FOR SECOND  
CONSIDERATION**

Senator Jordan reports for the Standing Committee on Reference, recommending that the following bills and resolutions, standing in order for second consideration, be referred to committee as recommended:

To encourage hospitals and freestanding birthing centers to adopt policies and procedures that promote breastfeeding.

To the Committee on Medicaid, Health and Human Services.

**S. C. R. No. 38**-Senators Lehner, Beagle, et al.

To recognize the valuable work of pregnancy resource centers and their positive, life-affirming impact on women, men, babies, and communities.

To designate the week of May 4, 2014, to May 10, 2014, as "Ohio Junior Chamber International Senate Week."

To amend sections 2925.11, 2925.12, 2925.14, and 2925.141 and to enact section 2925.142 of the Revised Code to provide a qualified immunity from arrest, prosecution, conviction, penalizing, and supervised release sanctioning for a minor drug possession offense or a drug paraphernalia possession or use offense for a person who seeks assistance for self or another person who is experiencing an emergency drug overdose.

To enact section 5120.71 of the Revised Code to require the Director of Rehabilitation and Correction to establish programs in state correctional institutions to teach and promote entrepreneurship.

To enact section 5.2296 of the Revised Code to designate May as "Asthma Awareness Month" and to designate May 5 as "Childhood Asthma Awareness Day."

**S. B. No. 316**-Senator Cafaro, et al.

To amend sections 109.573 and 2933.82 of the Revised Code to require a law enforcement agency to review the agency's records pertaining to sexually oriented offenses within one year and to forward the contents of a sexual assault examination kit in the agency's possession to the Bureau of Criminal Identification and Investigation or another crime laboratory for DNA analysis

based on the outcome of the agency's review, to require a law enforcement agency to forward the contents of a sexual assault examination kit to the Bureau of Criminal Identification and Investigation or another crime laboratory for DNA analysis within twenty days after the agency determines that one or more persons may have committed or participated in a sexually oriented offense or another offense committed during the course of a sexually oriented offense, and to prioritize the order in which the DNA specimens forwarded by law enforcement agencies undergo DNA analysis.

To enact section 9.318 of the Revised Code to require state agencies to purchase only uniforms and other apparel items that are made with American textiles, materials, and supplies.

To amend section 5119.41 of the Revised Code to set the countable resource limit for the Residential State Supplement program at \$2,000.

To amend section 5709.07 of the Revised Code to exempt church day-care centers from property taxation, provided the day-care center does not produce over \$30,000 in income for the church per year.
