The following bills were introduced and considered the first time:

S. B. No. 359-Senators Beagle, Lehner.

Cosponsors: Senators Turner, Brown, Schiavoni.

To amend sections 3737.82, 3781.10, 3781.104, and 4740.14 of the Revised Code to require a separate, exterior means of egress for dwelling areas above the second story of certain residential rental properties.

S. B. No. 360-Senator Schiavoni.

To enact section 5534.40 of the Revised Code to designate the bridge spanning the Meander Creek Reservoir on Interstate Route 80 in Mahoning County, as the "Fire Chief Andrew R. Frost, Jr., Bridge."
