**HOUSE AMENDMENTS TO SENATE BILLS AND RESOLUTIONS**

To amend sections 4725.01 and 4725.091 and to enact sections 3901.81, 3901.811, 3901.812, 3901.813, 3901.814, and 3901.815 of the Revised Code to establish standards for the performance of pharmacy audits in Ohio and to authorize the continued use of certain analgesic controlled substances in the practice of optometry, were taken up.

Senator Sawyer moved that the House amendments to **Am. Sub. S. B. No. 258**, be informally passed and that they retain their place on the calendar.
