BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO:

WHEREAS, Wrestling is a sport that epitomizes the Olympic7spirit of competitiveness and sportsmanship. Wrestling represents8the determination and hard work that it takes to succeed in life9as well as sports; and10

WHEREAS, Wrestling was one of the original sports in the11ancient Greek Olympiads as well as the first modern Olympic Games12in 1896. Because wrestling is recognized as one of the world's13oldest competitive sports dating back to 3000 B.C., wrestling14events deserve to be revered as a time-honored tradition at the15international competition level; and16

four Ohio universities have NCAA Division 1 wrestling programs; 20 and 21

WHEREAS, The decision of the International Olympic Committee 22 Executive Board to remove wrestling as an Olympic core sport and 23 thus remove it from the Summer Olympic Games beginning in 2020 24 threatens the potential successes of young Ohio athletes who have 25 trained their minds and bodies in the hopes of competing in the 26 Olympic Games, a supreme achievement for athletes. Aspirations of 27 wrestling on the Olympic stage are crucial to coaches and student 28 athletes participating on school wrestling teams and in 29 organizations such as the Ohio Regional Training Center; now 30 therefore be it 31

RESOLVED, That we, the members of the House of 32 Representatives of the 130th General Assembly of the State of 33 Ohio, in adopting this resolution, strongly urge the International 34 Olympic Committee Executive Board to reverse its decision to 35 eliminate wrestling from the Summer Olympic Games beginning in 36 2020 and reinstate wrestling as a core sport of the Summer Olympic 37 Games; and be it further 38

RESOLVED, That we, the members of the House of 39 Representatives of the 130th General Assembly of the State of 40 Ohio, strongly urge the U.S. Olympic Committee to work actively to 41 reverse the International Olympic Committee Executive Board's 42 decision to remove wrestling from the Summer Olympic Games 43 beginning in 2020; and be it further 44
