## ACT SUMMARY

• Includes alpacas and llamas, by inclusion in definitions, in the laws governing financial assistance for livestock exhibitions at the state fairgrounds, livestock exhibitions, concentrated animal feeding facilities, licensure of livestock dealers, and registration of livestock brands.

## **CONTENT AND OPERATION**

The act includes alpacas and llamas in the definitions of "species," "livestock," "agricultural animal," and "animals" in the laws that are summarized below.

Licensure requirements governing livestock dealers	"Animals" or "livestock"	Horses, mules, and other equidae, cattle, sheep, and goats and other bovidae, swine and other suidae
Registration requirements governing livestock brands	"Livestock"	Cattle, sheep, goats, and other animals of the family bovidae, swine and other animals of the family suidae, and horses, mules, burros, asses, and other animals of the family equidae
